A response to a cease-and-desist letter related to a Brown Act violation was issued. The Governing Board discussed the Student Equity Plan, which was approved unanimously. Board Policy 7400 regarding employee travel was updated. The Palomar Faculty Federation (PFF) requested an agenda item to discuss Board Policy 3000. The Board also expressed interest in raising concerns related to artificial intelligence. Governing Board meeting dates and times were approved, with one meeting scheduled to be held at the Rancho Bernardo Center. Open session for meetings is set to begin at 5:15 p.m.
